

WELFARE ADMINISTRATIVE SERVICES

This budget has decreased from \$1,706 last year to \$1,621 this year, representing a 5% decrease.

Funds are contributed to the STOP Organization which provides a number of programs in Southampton County. A synopsis of their organization (from www.stopinc.org) is reprinted below:

The Southeastern Tidewater Opportunity Project, Inc. (STOP) is a non-profit organization dedicated to alleviating poverty in the Tidewater area. Since its establishment in 1965, STOP has grown to become the largest community action program in the Commonwealth of Virginia. Its main offices are centrally located in the city of Norfolk; satellite offices are maintained in the seven cities and two counties served by STOP.

The forging of partnerships with local, state and federal agencies, as well as the community - based organizations, creates an extensive network for providing quality services to our customers.

The STOP Organization has been far more innovative and responsive than most social programs. It is viewed by city leaders as a program development agency with several exemplary programs such as Head Start, Home Weatherization, Certified Nurses Aide, Job Readiness and Community Outreach.

The STOP Organization is governed by a volunteer Board of Directors consisting of elected officials or their designees, business and civic leaders, and target area residents. The administrative staff is headed by an executive director who oversees approximately 630 staff members. The organization maintains eight active Community Services Advisory Councils.
